A3.20 Trunk Lines

A3.20.1 General

- A. Business trunks are provided on a flat rate basis, or Area Calling Service basis where available. On or after August 4, 1976, Message Rate Trunk Service is offered to new subscribers only for hotel and hospital services (See A103.7.2). The provision of all of the preceding services is subject to any other restrictions in this and any other applicable *service publication*. (C)
- B. Hospital, hotel, rest home and nursing home subscribers may combine flat and message rate service or flat and Area Calling Service on a premises. Area Calling Service and message rate service may not be combined on a premises. These trunks are provided at the rates stated in *paragraph* A3.20.8 for the appropriate service. (C)
- C. Hotels, hospitals, rest homes and nursing homes may subscribe to Area Calling Service, flat rate service or message rate service. Guests may contract separately for one of the residence services otherwise available to them. (C)
- D. Grouping service is provided for trunk lines at the rates specified in A3.19. (T)

A3.20.3 Trunk Enhancements

- A. In addition to the charges stated in A3.20.2., optional premium service may be furnished to improve transmission specifications on a trunk which will provide a maximum 1004 Hz loss of 5.0 dB. Basic services provide a maximum 1004 Hz loss of 10.0 dB.
- B. Service order charges and central office line connection charges will apply as specified in Section A4. These charges will be waived for a 90 day period following the effective date of this guidebook for those customers who choose the basic service and then choose to convert to the optional premium service.
