### A3. BASIC LOCAL EXCHANGE SERVICE

#### A3.1 General (Cont'd)

- I. Pursuant to KPSC Administrative Case No. 2016-0059, a monthly Intrastate Universal Service Surcharge shall be imposed on all local exchange access lines, MultiServ service lines and MultiServ PLUS service lines or in the case of ESSX service and Centrex service, per Network Access Register (NAR). For purposes of application of this surcharge, access lines are defined as facilities which provide access to and from the telecommunications network for toll service and for local calling with the exception of WATS, Remote Call Forwarding, Radio Common Carriers, InterLATA Foreign Exchange Lines, Private Line Services, Mobile, Interexchange Carriers, and Company Official Accounts. The Commission has determined in KPSC Administrative Case No. 2016-0059, Order dated March 1, 2016, that the amount of the surcharge will be \$.08 per access line; however, this amount is subject to change by the Commission to meet the needs of the Universal Service Fund in Kentucky. The surcharge shall appear as a separate line item on the customer's bill.
- A Cost Assessment Charge (CAC) is assessed on a per access line basis for residential and business customers. The CAC recovers ongoing costs associated with the administration of Local Number Portability. This charge is not a tax or fee that the government requires AT&T to collect from customers. The following will not be assessed a CAC: Resale, Lifeline, 911 Services, Coin services and Federal, State, and Local Government accounts.

Charges for local usage are specified in A3.2, and are based on mechanized records kept of all calls originated on the line.
