A3. BASIC LOCAL EXCHANGE SERVICE

A3.1 General (Cont'd)

I. Pursuant to KPSC Administrative Case No. 2016-00059, a monthly Intrastate Universal Service Surcharge shall be imposed on all local exchange access lines, MultiServ service lines and MultiServ PLUS service lines or in the case of ESSX service and Centrex service, per Network Access Register (NAR). For purposes of application of this surcharge, access lines are defined as facilities which provide access to and from the telecommunications network for toll service and for local calling with the exception of WATS, Remote Call Forwarding, Radio Common Carriers, InterLATA Foreign Exchange Lines, Private Line Services, Mobile, Interexchange Carriers, and Company Official Accounts. The amount of this surcharge is established and subject to change by the Commission to meet the needs of the Universal Service Fund in Kentucky. The surcharge shall appear as a separate line item on the customer's bill.

A3.2 Statewide Rate Schedules

A3.2.1 Flat Rate Schedule

The rates specified herein entitle subscribers to an unlimited number of messages to all stations bearing the designation of central offices within the serving exchange and Limited Local Calling Area exchanges as shown in A3.6, Local Calling Areas.

Charges for local usage are specified in A3.2, and are based on mechanized records kept of all calls originated on the line.
