PURPOSE: BellSouth Telecommunications, LLC d/b/a AT&T Kentucky intends to retire copper facilities in distribution area (DAs) 3109c, 4115, and 4112a of the Bowling Green wire center (BWLKGYMA), due to the impact of a planned Kentucky Department of Transportation (KYDOT) road move project. This road construction will improve the 31-W By-pass, and KYDOT has requested AT&T Kentucky remove or relocate its facilities in the way of this road project before November 17, 2023. plans to migrate copper facilities customers to existing Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) facilities and retire the copper facilities.
