PURPOSE: TDM to IP Transition - Frankfort, KY LLC d/b/a AT&T Kentucky (AT&T Kentucky) intends to retire copper feeder and distribution facilities serving Distribution Area (DA) 3104 in the Frankfort Main (FRFTKYMA) wire center in Frankfort, KY due to a planned Kentucky Department of Transportation (KYDOT) road move associated with the Singing Bridge Project and other construction activity within the DA. KYDOT had requested that AT&T Kentucky remove or relocate facilities that may be in the way of this project by March 30, 2026. sible, to existing Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) facilities and, once migration is complete, retire the associated copper cable and facilities.
