Kentucky Department of Transportation has requested AT&T Kentucky to remove or relocate its facilities in the way of this project before August 30, 2025. tucky plans to migrate customers currently served by copper facilities to existing Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) facilities and then retire the copper facilities.
