A3. BASIC LOCAL EXCHANGE SERVICE

A3.1 General

- A. Rates for basic local exchange service are related to the total main station lines; main Centrex Type Services station lines and private branch exchange trunks in the Basic Local Calling Area as described in A3.6.
- B. Base Rate Areas, Zone Rate Areas, and Exchange Service Areas for each exchange are identified on maps filed as a supplement to the tariff.
- C. The rate for service and equipment not specifically shown in this section are presented in other sections.
- D. Individual main station line service is comprised of serving central office line equipment and all outside plant facilities needed to connect the serving central office with the customer premises at the demarcation point. These facilities are Company-provided and maintained and provide access to and from the telecommunications network for message toll service and for local calling appropriate to the offering selected by the customer.

- F. As authorized in LPSC General Order dated April 29, 2005, a monthly surcharge may be imposed for the recovery of expenses paid to the State Universal Service Fund (SUSF). This fee/surcharge will appear on retail (not wholesale) customer bills as "LA Universal Service Fee" and will be applied to access lines, trunks and NARs (Network Access Registers). The fee will not be applied to Lifeline services, private lines or ISDN B-channels.

Service Charge is a nonrecurring charge or charges applying to the ordering, installing, moving, changing, rearranging or furnishing of telecommunication services or facilities. Service Charges are categorized as:

- Line Connection Charge
- Line Change Charge
- Secondary Service Charge
- Premises Work Charge

Line Connection Charge (First Line and/or Additional Line) applies for establishing an exchange access line or trunk. The charge includes service ordering, central office work, exchange access line work and a standard voice miniature six position network interface.

Line Change Charge (First Line and/or Additional Line) applies per line to miscellaneous customer requested changes on existing service for, but not limited to, number change and suspend/restore.

Secondary Service Charge applies per customer request for the receiving, recording, and processing of customer requests to change services or add new or additional services.

Premises Work Charge is a nonrecurring charge based on the labor time and miscellaneous materials required to rearrange the drop wire, protector and/or network interface.

CUSTOMER REQUEST

The term "per customer request" as used in this section shall be defined as a customer request for service that is ordered at the same time to be provided on the same date, the same premises, the same system, and the same account.

NETWORK INTERFACE

The network interface is a FCC approved standard registration program jack which is used at the demarcation point as a means of connection between the telecommunications network and the customer's inside wire and/or equipment.

DEMARCATIION POINT

The point of demarcation and/or interconnection between Company communications facilities and the customer's terminal equipment, protective apparatus or wiring at a subscriber's premises.¹ Company-installed facilities at, or constituting, the demarcation point shall consist of wire or a jack conforming to Subpart F of Part 68 of the Federal Communications Commission's rules.

- A. The appropriate Line Connection Charge, Secondary Service Charge or Line Change Charge applies in addition to the Premises Work Charge.

The sum of their time is used to determine the number of 15-minute increments to be billed. A4.5 Service Expediting Charge

A4.5.1 General

- A. When the customer requests that service be provided in advance of the established service interval, and the Company is able to comply, a Service Expediting Charge applies. The Company will determine minimum intervals required to provide service and will not expedite in advance of such intervals. These minimum intervals may vary according to the type of service requested and/or the location where the service is to be provided.
- B. The charge is applicable per exchange, per customer request, as defined in A4.1.
- C. The charge applies in addition to all other service and installation charges normally applicable.
- D. The definition of an established service interval, for purposes of applying this charge, is that interval which was agreed to by the Company and the customer during the initial negotiation for service, where flexible dates are available or where predetermined intervals must be offered.
- E. For requests to expedite service to the normal plant test date from the established due date for lines or trunks requiring engineering design, a charge equal to the Secondary Service Charge will apply in lieu of the expedite charge shown. This charge is in addition to the normal service charges applicable on the request.
- F. If the Company commits to an expedited service date and then fails to meet the commitment, the customer shall not be responsible for the Service Expediting Charge and the Company shall have no further liability to the customer for its failure to meet the commitment.

Must apply for and receive a Certificate of Authority to Operate number from the Louisiana Public Service Commission (LPSC), as required by LPSC General Order dated March 30, 1995, before the Company connects the public telephone access line(s). Proof of Certification must be furnished to the Company.
 - c. The instruments must be able to accommodate the hearing impaired and handicapped persons.
 - d. The instruments must be installed in compliance with the National Electrical Safety Code.
 - e. There shall be no charge to the station user for Directory Assistance calls dialed (1+411 and 1+555-1212) from a ten-cent customer-provided public telephone. The charge to the station user for Directory Assistance calls (1+411 and 1+555-1212) from any other customer-provided public telephone is not to exceed the maximum amount authorized by the Commission for a Company coin telephone in that exchange.
 - f. Non-chargeable Operator, 911 and 800 numbers, must be able to be made without a coin deposit, and with no time limitation.
 - g. Emergency numbers (Operator Assistance and 911) must be clearly posted at each instrument location.
 - h. Information must be displayed on the instrument consisting of
 - (1) the Certificate of Authority to Operate number issued by the Louisiana Public Service Commission,
 - (2) the address and telephone number where a caller can obtain assistance in the event the instrument malfunctions in any way, and
 - (3) procedures for obtaining a refund from the owner.
 - i. The instruments must have any and all operating instructions posted thereon.
 - j. The charge to initiate a local call is not to exceed the maximum amount authorized by the Commission for a Company coin telephone in that exchange including those stations located in public assisted housing projects, hospitals, and nursing homes.
 - k. Coins must be returned by the instruments for any incomplete calls.
 - l. All repairs shall be performed on the instruments, within a reasonable amount of time, the responsibility for which is placed upon the owner of the telephone.
 - m. **(DELETED)**
 - n. A subscriber must order a separate public access line for each instrument installed and will be billed the tariff rate for each such access line.

18. Emergency Service Numbers (ESNs) are only available as part of the Selective Routing feature. Single and Multi-PSAP customers who desire to use ESNs for administrative purposes may do so as long as they subscribe to Selective Routing. Administrative ESNs can only be used to identify a unique set of responding agencies. For the purposes of this Tariff, a responding agency is defined as a municipality's police, fire, emergency medical service or other appropriate agency. ESNs will not be assigned to specific police precincts, fire stations, emergency medical zones, etc.
19. The customer is responsible for preparing a map with a complete list of road names and another map that identifies jurisdictional boundaries. This includes the naming and/or renumbering of streets and the assignment of numbers for previously unnumbered property. This information is then merged with Company records to form the initial Master Street Address Guide (MSAG). The customer is provided prints of the MSAG for verification and correction purposes at various intervals in the creation process. The Company may assist the customer through the provision of information from its records concerning the names, telephone numbers and service addresses of subscribers within the customer's serving area.
20. The following terms define the customer's responsibilities with respect to any information provided by the Company to the customer concerning the Company's subscribers and/or with respect to geographical information or maps:
 - a. Such information shall be used by the customer solely for the purpose of aiding the customer in more accurately identifying, updating and/or verifying the addresses of subscribers within the customer's E911 serving areas in connection with the customer's provision of E911 services.
 - b. Customer shall strictly limit access to the information to those authorized employees of the customer with a need to know and those employees actually engaged in the provision of emergency assistance services.
 - c. Customer shall use due care in providing for the security and confidentiality of the information.
 - d. Customer shall make no copies of the information except as may be essential for the verification of emergency assistance services.
 - e. As soon as customer has completed using the information for the purposes authorized in the Tariff or upon the request of the Company, customer shall return all information and all copies of information to the Company or certify that the information has been destroyed.

A35.3.3 Obligations of the Mobile Service Provider (MSP)

- A. The MSP's switch must be capable of using Operator Services System signaling as described in Bellcore document TR-TSY-000506.
- B. A screening number must be provided by the MSP for Operator Service Interconnection. The chosen telephone number can only then be used in the provisioning of this service. The MSP may use a telephone number from an existing dedicated NXX. However, the MSP must use a telephone number from a dedicated NXX to achieve customer branding.

A35.3.4 Application of Rates

- A. Operator Services Interconnection is comprised of a distance-sensitive facility rate from the MSP's premises to the MSP's serving wire center and a trunk termination rate for terminating equipment located at the TOPS switch. MSP Usage charges will apply for DACC completed calls. Other applicable charges will apply for general operator assisted calls.
- B. Operator Services Interconnection is only available in twenty-four channel increments.
- C. MegaLink service, MegaLink Light service and LightGate service from Section B7. of the Private Line *Guidebook* are used to rate the facilities used for Operator Services Interconnection. The terms and conditions which apply for those services apply here, including the application of any service establishment charges. (T)
