Complete Choice service with Local Optional Service or Local Optional Service Option B with the Complete Choice option provides the features specified following and an individual access line with Local Optional Service or Local Optional Service Option B. Each line includes Touch-Tone capability.
2. The rates specified herein for Complete Choice service entitle a residence subscriber to unlimited calling to all exchange access lines in the subscriber's exchange and in the additional exchanges in the subscriber's basic local calling area as specified in A3.6. *Terms, conditions*, local calling areas, usage packages and usage rates specified in A3.2.9 or A3.2.10 apply for an access line with Local Optional Service or a Local Optional Service Option B access line, respectively. 3. The rates specified herein also entitle a residence subscriber to unlimited use of the services/features specified in the following sections:

 - 2. A Service Cancellation Fee (SCF) is applicable at the date of termination and is reduced by 1/36, 1/60 or 1/84 per month from the date of installation, respective to the choice of rate periods. This fee will be equal to 36, 60 or 84 times the monthly rate at the time the service is established.
 - 3. The multiline service rates (A103.21.2.E.) in effect when the Company is notified in writing of the subscriber's choice of payment period option, will be applicable for the duration of the payment period chosen by the subscriber. Local Optional Calling Plans are specially designed local calling plans applicable to certain local messages within the Expanded Local Calling Area as described in Section A1. for which the subscriber-dialed, station-to-station Expanded Local Calling Area Service rate would normally apply. Local Optional Calling Plan rates take precedence over the Local Parish Calling Plan rates specified in A3.32.4 All other messages included under the plan will also vary according to the specific plan subscribed to. Messages not included in the plan will be billed at rates for Expanded Local Calling Area service.

One-way Local Measured Circle Calling Plans include Expanded Local Calling Area calls originating at any hour, outward from the Local Optional Calling Plan subscriber's telephone to any Bell or Independent Company exchange within the mileage distance specified in the plan. Distance is based on airline mileage between wire centers. Wire Center Coordinates are specified in A3.36.

B. Two-Way Local Measured Circle Calling Plans

Two-way Local Measured Circle Calling Plans include:

1. Expanded Local Calling Area calls originating at any hour, outward from the Local Optional Calling Plan subscriber's telephone to any Bell or Independent Company exchange within the mileage distance specified in the plan, and
2. All Expanded Local Calling Area calls in the reverse direction originated by any telephone within the mileage distance specified to the telephone of the subscriber to the plan. The called subscriber is billed for measured and message rated calls from the Expanded Local Calling Area at the local optional calling plan rate. The calling subscriber is billed for measured and message rated calls from the Basic Local Calling Area at the appropriate local usage rate. Usage time on calls in both directions will be accumulated and the total time thus determined will apply as total usage for the month in which billed. Should both the called and calling numbers be two-way local measured circle calling plan subscribers, each in the other's calling area, the called subscriber is charged for the call at the local optional calling plan rate. Distance is based on airline mileage between wire centers. Wire Center Coordinates are specified in A3.36.

C. Local Tele-Thrift

Local Tele-Thrift will be offered when associated with Residence Individual Line Service.

Local Tele-Thrift is furnished only on dial station-to-station calls originating one-way outward from the Local Optional Calling Plan subscriber's telephone to telephones within the Expanded Local Calling Area during the hours specified.

A. Liability Of The Company

1. In view of the fact that the customer has exclusive control of his communications over the facilities furnished him by the Company, and of the other uses for which facilities may be furnished him by the Company, and because of unavailability of errors incident to the services and to the use of such facilities of the Company, the services and facilities furnished by the Company are subject to the terms, conditions and limitations herein specified.
2. Neither this Company nor any connecting carrier participating in the service shall be liable for any act or omission of any other company or companies furnishing a portion of such service.

A. Liability Of The Company (Cont'd)

3. In view of the possibility of errors and difficulties in the transmission of messages by telephone and the impossibility of fixing in all cases the causes thereof, the Company cannot guarantee uninterrupted working of its lines. The liability of the Company for damages arising out of mistakes, omissions, interruptions, delays, or errors or defects in transmission occurring in the course of furnishing the service, which is not due to the negligence or willful act of the subscriber, or of the Company in failing to maintain proper standards of maintenance and operation and to exercise reasonable supervision, shall not exceed a pro rata adjustment of the fixed monthly charges for the service and facilities rendered useless and inoperative, during the period of said interruption. Adjustments will not be applicable on Measured Rate Service until the subscriber has used a minimum of one hour's service in a given month.

1. Offering of this service is subject to availability of facilities and/or billing capability as determined by the Company. One-way Local Measured Circle Calling Plans and Local Tele-Thrift are not offered for new installations or transfers of service to new locations.
2. One-way service is not available to hotel, motel or hospital PBX subscribers for use by their patrons. Two-way service is available to those exchanges listed in A103.33.3.A.2. following.
