### A40.5.3 Fast Packet Option (FPO)

#### A. General

- The Fast Packet Option (FPO) of Broadband Line Service is only available when used in conjunction with Frame Relay Service or Asynchronous Transfer Mode (ATM) Service. Specifications for Frame Relay Service are contained in A40.1. ATM Service specifications are contained in A40.8.
- 2. The Fast Packet Option is used to connect a customer premises with the Frame Relay or ATM Network Serving Areas.
- 3. The Fast Packet Option is designed to transmit digital data signals at speeds of 56 Kbps, 64 Kbps, 128 Kbps<sup>1</sup>, 1.536 Mbps, 44.210 Mbps, 149.760 Mbps, or 599.040 Mbps.
  - a. Multiples of 1.536 Mbps Broadband Line Service and Broadband Line Extension Service (from 2 through 8) may be used to access ATM Service Customer Connections using Inverse Multiplexing (IMA).
