B3.3.3 Mileage Measurements (Cont'd)

A. (Cont'd)

- 6. Obtain the square root of the result obtained in 5. This is the rate distance in miles. (Fractional miles being considered as full miles.)

EXAMPLE: The rate distance is required between City One and City Two.

City One	7260	2083
City Two	7364	1865
Difference	104	218
Squared	10,816 + 47,524 = 58,340	

58,340 divided by 10 = 5834

Square root of 5834 = 76.38 = 77 Airline miles

- B. For the purpose of applying multipoint charges, the bridging or hubbing locations are determined by that combination of airline distances connecting the serving wire center which will produce the lowest interoffice mileage charges. Bridging charges apply when three or more channels connect at the same location.
- C. For Series 1000, 2000 and 6000 channels the customer may specify the sequence in which the service points are to be connected in which case the rate mileage is the shortest airline mileage determined in accordance with B., which will connect the wire centers of the service points in the specified sequence.

- C. Conditioning (Voice Grade Services)

- 1. Conditioning provides more specific transmission characteristics for data services. There are two types of C-conditioning and one type of D-conditioning, each with different technical specifications. C-Type conditioning controls attenuation distortion and envelope delay distortion. D-Type conditioning controls the signal to C-notched noise ratio and intermodulation distortion.

Conditioning is charged for on a per Local Channel basis for two-point and multipoint service. For two-point services the parameters apply to each service. For multipoint services the parameters apply to any path between any two service points.
