LDOT has requested AT&T Louisiana to remove or relocate its facilities in the way of this road project before January 28, 2025.ans to migrate copper facilities customers to existing Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) facilities and retire the copper facilities.
