PURPOSE: BellSouth Telecommunications, LLC d/b/a AT&T Louisiana intends to retire copper facilities in distribution area (DA) 212701 of the Baton Rouge Main wire center (BTRGLAMA), due to the impact of a planned Louisiana Department of Transportation (LDOT) road move project. LDOT has requested AT&T Louisiana remove or relocate its facilities in the way of this road project before November 27, 2024. Plans to migrate copper facilities customers to existing Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) facilities and retire copper facilities.
