- A. Local Optional Service Option B is an optional offering that provides local calling to the Basic Local Calling Area and the Expanded Local Calling Area as described in Section A1.
- B. This service is not available to customer-provided public telephone subscribers or subscribers of Shreveport Metropolitan Calling and Expanded Local Area Calling.
- C. Customers subscribing to Local Optional Service Option B will be provided an access line and usage package as described following.
- D. The basic access line for Residence and Business service is provided at the following rate. A residence access line with the Complete Choice option is provided at the rate specified in A103.2.11. All other services offering Local Optional Service Option B are provided in the appropriate sections. See Section A3.20 for Local Optional Service Option B Trunks.

Local usage charges for hotel /motel guest room service and Shared Tenant Service will not be capped. The per-line cap for specified local usage charges is applied on an account basis. This option includes a usage allowance of \$4.00 per month on all calls terminating in Bands 0 and A - E. Local calls are billed in accordance with the usage schedule described in paragraph F, at a 20 percent discount on the total usage charges, in addition to the off-peak discount described in paragraph H. Billed usage charges in Bands 0 and A - E in excess of the allowance are capped at \$11.00 per month, per residence line or \$21.00 per month, per business line, trunk, MultiServ service main station line, MultiServ PLUS service NAR, BellSouth Centrex service NAR, ESSX service NAR or Digital ESSX service NAR with the following exception. Local usage charges for hotel/motel guest room service and Shared Tenant Service will not be capped. The per line cap for specified local usage charges is applied on an account basis. The cap for an account is equal to the number of lines, trunks or NARs on the account times the appropriate per line cap. **A9. FOREIGN EXCHANGE SERVICE AND FOREIGN CENTRAL OFFICE SERVICE**

**A9.2 Foreign Central Office Service**

Except as otherwise indicated for Wire Centers in Section A2.3.1.E, effective October 15, 2025, Foreign Central Office Service will no longer be available for purchase by new customers or new accounts for existing customers. In addition, requests to move, add, or physically change service arrangements will not be accepted.

**A9.2.1 General**

- A. Foreign Central Office Service is exchange service furnished to a subscriber in a multi-office exchange from a central office other than the one from which service would normally be furnished.
- B. Foreign Central Office Service is offered in connection with Individual Line Main Station Service, PBX Service and Centrex Type Services only.
- C. Other services, equipment or facilities used in connection with Foreign Central Office Service, except as otherwise indicated in this Guidebook, are furnished subject to the rates, terms and conditions applying in the foreign central office from which the subscriber is served.
- D. Alternate routing of this service may be provided on a direct serve basis to the subscriber's premises from the requested foreign central office on an individual case basis as specified in Section A5, subject to the following conditions:
  - 1. The subscriber must maintain a minimum of fifty percent of the trunks/lines from the central office from which service would normally be furnished.
  - 2. Rates and charges for all components of the service will continue to apply as specified in A9.2.2.A. and B, with the exception of those applicable for Type 2145 channel(s). The monthly rate for the class of service desired will be based on the rates applicable from the foreign central office, but will be no less than the rates for that service from the subscriber's normal serving wire center. Additionally, rates and charges as specified in A5 will apply on an individual case basis.

**A9.2.2 Rates And Charges**

**A. Methods Of Applying Rates**

The rate for Foreign Central Office Service is the monthly rate for the class of service desired, plus a foreign central office mileage charge as shown in A9.2.2 for the distance, airline measurement, between the central office from which the subscriber would normally be served and the foreign central office (i.e., the central office from which the subscriber desires to be served). In addition the subscriber is charged any Zone Charges which would apply for connection with the central office from which service would be rendered.

**A12.8 Identified-Outward Dialing (IOD) From Private Branch Exchange Systems**

- A. The service is furnished subject to the availability of facilities and numbers.
- B. The service includes the central office equipment necessary for identification of outgoing toll calls and billing of toll calls by number.
- C. The service must be provided on all trunks or lines in a group.
- D. The minimum contract period for the service is three years. In case of discontinuance or reduction of service within the minimum contract period a basic termination charge as shown in the rates below, reduced by 1/36 for each full month of service provided, shall be applied.
- E. Where Identified-Outward-Dialing is requested on more than one group of trunks or lines, each such group shall be considered a separate service.
- F. The rates herein contemplate the use of standard equipment and serving arrangements. When equipment or service of a special type is requested and provided, rates and charges are based on the additional costs involved to meet the individual requirements of each case.
- G. Operational characteristics of interface signals between Company-provided connecting arrangements and customer-provided equipment must conform to the terms and conditions the Company considers necessary to maintain proper standards of service.
- H. The Company shall not be responsible to the customer or authorized user or joint user if changes in protection criteria or in any of the facilities, operations or procedures of the Company render any facilities provided by a customer, authorized user or joint user obsolete or require modification or alteration of such equipment or system or otherwise affect its use or performance.

- Note 1:** In addition to the rates and charges for DID terminations, rates and charges for Flat Rate Inward or DID Combination Trunks as specified in A3 apply as appropriate.
- Note 2:** Combination Trunks with the Call Transfer feature are only provisioned from 5ESS switches where facilities permit.
- Note 3:** Provide faster signaling on DID trunks. The choice of pulsing alternative depends on the customer's premises equipment
- Note 4:** Provides automatic intercept and referral of calls from a non-listed disconnected DID number to a standard central office recorded announcement for twelve months or until the delivery of the new directory, whichever comes first. AIS is available only where facilities permit.

**A13.56.1 General**

- A. Hot Line Service is an automatic dialing feature which provides the customer with the ability to automatically be connected with another line in the circuit switched network. When the customer's telephone instrument goes off-hook, a switched connection is set up without any further action.
- B. Hot Line Service may be used only in connection with individual line service.
- C. Hot Line Service is furnished only from central offices which have been arranged to provide this service and is provided subject to the availability of facilities.
