SECTION 3 - SERVICE DESCRIPTIONS AND RATES

3.1 General

The Company provides international switched telecommunications services between locations in the United States and applicable international points and between applicable international points shown in the individual product descriptions in this Guide. The Company's service includes direct-dialed and operator assisted calling with charges based upon call duration, mileage, and/or total volume. Access to the Company's international service may be via switched access. (D)

3.2 Calculation of Distance

Charges for all mileage sensitive services are based on the airline distance between the vertical and horizontal coordinates of the rate centers associated with the originating and terminating central offices serving the Customer and the called party. The applicable usage rates for the billing of a distance sensitive call shall depend on the distance in airline mileage between the originating and terminating points of the call, as calculated utilizing telecommunications industry standards.

For calls originated by dialing a local exchange number or a 950-type number using an Authorization Code, the originating point shall be the rate center in which the shared access facilities are located. For calls originated via Equal Access connections or WATS Access Lines, the originating point shall be the rate center in which the Customer is located. The terminating point shall be determined by the rate center of the called number.

3.2.1 The following Vertical (V) and Horizontal (H) coordinates for U.S. Mainland/Mexico border crossing locations are not obtained by reference to industry standard documents and must be utilized in calculating the distance for both portions of a U.S. Mainland to Mexico call.

3.3 Mexican Connections

All calls to Mexico are rated utilizing one of two methods.

The first method rates calls in two steps. The first step is to determine the mileage from the originating U.S. Mainland location to the border crossing point associated with the destination city in Mexico (U.S. Mainland Portion). The rate for the U.S. Mainland Portion is based on the resulting mileage band as computed according to Section 3.2 of this Guide. The second step in this method of rating calls to Mexico is to determine the Rate Step applicable from the border crossing point identified in the first step to the terminating city in Mexico (Mexico Portion). The Rate Steps are defined by the Mexico Telecommunications Authority.

The second method rates calls based upon Rate Steps from the border crossing point associated with the terminating city in Mexico. The Rate Steps are defined by the Mexico Telecommunications Authority.

Each individual product defines which pricing methodology is used for that particular product.

3.4 Call Timing

- 3.4.1 Long distance usage charges are based on the actual usage of the Company's network. Chargeable time for Operator Station calls begin when the calling and the called station are connected. Chargeable time for Person to Person Calls begins when the connection is made between the calling person and the particular person, department, or extension specified or an agreed upon alternate. (D)
- 3.4.2 Chargeable time ends when the calling service point terminates, thereby releasing the network connection. If the called party hangs up but the calling number does not, chargeable time ends when the network connection is released by signal from the called party location or by automatic timing equipment in the telephone network.
- 3.4.3 Unless otherwise specified in this Guide, the minimum call duration for billing purposes is one (1) minute.
- 3.4.4 Unless otherwise specified in this Guide, usage is measured and rounded in one-minute increments for billing purposes.
- 3.4.5 The Company shall not bill for unanswered calls in areas where Equal Access is available. The Company shall not knowingly bill for unanswered calls in areas where Equal Access is not available.

3.5 International Plan A

3.5.1 International Consumer MTS

This is a volume discounted Consumer calling plan utilizing Switched Access lines. Outbound calling and inbound (toll free) service are offered under this plan. There is no minimum monthly billing. (D)

Calls originate and terminate on switched facilities or equipment provided by local exchange companies or other authorized access providers. The Customer is responsible for establishing local access facilities or equipment and for all nonrecurring, recurring, construction and other charges in connection with such local access. The Customer using multiple Switched Access lines for a single international toll free number must arrange for hunting service from the local exchange company.

When the Company's International Service is used in conjunction with a corresponding domestic service, the applicable international charges is combined with interstate charges for the purpose of applying the volume discounts provided in the Company's Interstate Product Reference and Pricing Guidebook.

International MTS is an outbound service. Calls are billed in one minute increments with an initial period of one (1) minute

3.5.3 International to U.S. Toll Free Service, ITFS and UIFN

Toll Free Service provides the Customer with one or more telephone numbers which when dialed from stations in the international public switched network shall terminate on Customer-designated facilities or equipment. All charges accruing in connection with usage of the Customer's assigned numbers are billed to the Customer rather than to the party originating the call. All toll free service calls are billed in one-minute increments and are subject to a minimum billing of one minute. In addition to usage charges, the Customer is billed non-recurring and monthly recurring charges set forth in Table C.

- (A) ITFS - International Toll Free Service (ITFS) allows for the origination of toll free calls from international locations to be routed to a domestic toll free number. Different ITFS numbers must be requested for each country. ITFS countries are identified by a "N" in the UIFN column in Table A following.
- (B) UIFN - Universal International Phone Number (UIFN) is a service where calls are made to a special UIFN number that is common to all participating countries. Calls to the UIFN number are routed to a Customer's domestic toll free number. Assignment of the common UIFN number is managed by the International Telecommunications Union ("ITU"). UIFN applicable countries are identified by a "Y" in the UIFN column in Table A following.
