Description of Treatment of Certain Contracts or Agreements

1) Treatment of Certain Contracts or Agreements

Attached is a listing of those Mississippi tariff provisions applicable to services that have been deregulated effective July 1, 2006, and detariffed effective September 1, 2006. To the extent any subscriber or other party either entered into a contract or agreement with BellSouth prior to July 1, 2006 or, before such date, agreed upon the terms of a contract or agreement with BellSouth to be entered into after such date (and is bound by such commitment to enter into such agreement or contract), which references such tariff provisions, paragraphs 1 through 4 below shall apply. Without limiting the foregoing, to the extent any subscriber has purchased or contemplates purchasing any service (whether under a contract or agreement or otherwise) that has been detariffed, which service is subject to BellSouth's Comparably Efficient Interconnection ("CEI") Plans or BellSouth's Open Network Architecture ("ONA") Plan, paragraph 5 shall also apply.

- 1. For any contract or agreement for services pursuant to which the subscriber or other party has agreed to a defined service term commitment, any detariffed provision that is referenced in such contract or agreement shall continue to apply as a contractual term or condition for the remainder of the term commitment, unless provided to the contrary in such contract or agreement, as the same may be amended from time to time.
- 2. For any contract or agreement contemplating the ordering of any detariffed service on a month-to-month basis pursuant to rates, terms and conditions set forth in the detariffed portion of the tariff, the rates, terms and conditions governing such services on and after July1, 2006, shall be those set forth in the separate Service Agreement, Service Description and Price List applicable to such services, unless provided to the contrary in such contract or agreement, as the same may be amended from time to time.
- 3. For any contract or agreement between a subscriber or other party and BellSouth that contemplates the ordering of services that have been detariffed, all service-specific rates, terms and conditions for any detariffed services purchased on a month-to-month basis shall be subject to paragraph 2 above, except that where a provision of the Service Agreement directly conflicts with a provision of the contract or agreement between the subscriber or other party and BellSouth, the provision of the contract or agreement shall control. For any contract or agreement between a subscriber or other party and BellSouth that contemplates the ordering of services that have been detariffed, all service-specific rates, terms and conditions for any detariffed services purchased under a term commitment shall be subject to paragraph 1 above, except that where a detariffed provision directly conflicts with a provision of the contract or agreement between the subscriber or other party and BellSouth, the provision of the contract or agreement shall control.

- 4. For any contract or agreement between any subscriber or other party and BellSouth that contemplates the applicability of a referenced tariff provision to other services purchased pursuant to such contract or agreement, any detariffed provisions shall continue to apply for the remaining term of such contract or agreement.
- 5. Any reference to a tariffed service, tariffs or rates in a tariff, included in BellSouth's CEI or ONA Plans, which reference is to a service that has been detariffed, shall be deemed a reference to that section as set forth in the Service Agreement, Service Description and Price List applicable to such service.
