G. Terminating premium access or non-premium access, per minute charge(s) apply to: (Cont'd)

If a dispute arises concerning the customer provided quarterly percentage report, the Company may request the customer to provide the data the customer used to determine the percentage. The customer shall keep records from which the reported percentage credit can be ascertained. Upon request of the Company, the customer shall make records available for inspection as reasonably necessary for purposes of verification of the percentages and shall supply the data within 30 days of the Company's request. The Company will not request such data more than twice a year.

- H. The originating premium access or non-premium access, per minute charge(s) apply to all originating access minutes of use:
  - less those originating access minutes of use associated with BellSouth SWA FGA and BellSouth SWA LSBSA access services where off-hook supervisory signaling is forwarded by the customer's equipment when the called party answers;
  - less all originating access minutes of use associated with calls placed to 700, 800, and 900 numbers;
  - plus all originating access minutes of use associated with calls placed to 700, 800, and 900 numbers for which the customer furnishes a report of the percentage of minutes that terminate in a BellSouth SWA service that is assessed Carrier Common Line Access Service charges, and for which a corresponding reduction in the number of terminating access minutes of use has been made as set forth in G. preceding.
