MDOTusted that AT&T Mississippi remove or relocate its facilities in the way of this project before September 30, 2025.lans to migrate customers currently served by copper facilities to existing Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) facilities and then retire the copper facilities.
