

## TIME-OF-DAY ANNOUNCEMENT SERVICE /a/

## 1. General

- a. Existing installations may be retained by the customer at his present address. These installations will be maintained dependent upon availability of equipment from existing stock within this Company. No additions or changes will be allowed.

## 2. Description

- a. This service provides recorded time-of-day announcement, and is subject to the regulations in Tariff M.P.S.C. No. 20R, Part 2, Section 2. Time-of-Day Announcement Service requires a voice grade Direct Analog Service and may also require additional Special Access Services to connect the terminal equipment designated by the customer with the nearest central office equipped for distribution of continuous time service.

## 3. Regulations

- a. Time-Of-Day Announcement Service is furnished subject to the availability of facilities from the nearest central office equipped for distribution of continuous time service, as determined by the Company.
- b. The Company may discontinue furnishing Time-Of-Day Announcement Service to a customer when, as determined by the Company, its use unreasonably interferes with or impairs other telephone service rendered to the public by the Company.
- c. Suspension of Service is not offered for this service.

## 4. Charges

- a. There is no charge for Time-Of-Day Announcement Service. Established rates and charges apply for a voice grade Direct Analog Service and associated equipment and additional Special Access Services specified in Tariff M.P.S.C. 20R, Part 2, Section 7.

**TWO-WAY INTERCOMMUNICATION ARRANGEMENT /a/**

1. For a local channel facility in the same building, each two point service, the channels will be treated as same premises wire as specified elsewhere in this Guidebook or as different premises Direct Analog Service as specified in Tariff M.P.S.C. No. 20R, Part 21, Company's tariffs. (C)

**HOME INTERPHONE SERVICE**

1. Channels routed direct for Interphone Stations in different buildings will be treated as same premises wire as specified elsewhere in this Guidebook as different premises Direct Analog Service as specified in Tariff M.P.S.C. No. 20R, Part 21. (C)

**BUSINESS INTERPHONE SERVICE**

1. Channels routed direct for off-premises terminations will be treated as same premises wire as specified elsewhere in this Guidebook or as different premises Direct Analog Service as specified in (C) Tariff M.P.S.C. No. 20R, Part 21.

**CHANNEL CHARGES**

**A. CHANNELS FOR KEY TELEPHONE SYSTEMS**

1. Channels between different buildings on continuous or noncontinuous property, routed direct, will be treated as Premises Wire or Interpremises Wire. Charges are specified elsewhere in Section 72 of this Tariff.
2. Charges for cable (Premises Wire) for key sets are specified in Section 72 of this Tariff.

**B. CHANNELS FOR CENTRALIZED CUSTOMER INTERCEPT SERVICE**

1. When the exchange service termination is in a different building than the Switching Unit, voice grade Direct Analog Service rates and charges are applicable as provided via unregulated Dedicated Communications Service for end users and from Part 21, Special Access, for Telecommunications Providers.
2. When the Switching Unit is in a different building than the central intercept location, voice grade Direct Analog Services provided via unregulated Dedicated Communications Service are applicable for Supervisory Control Channels.

**A. AUTOMATIC VOICE CONNECTING ARRANGEMENTS**

1. General

Where now furnished these arrangements may be retained by existing customers at their present addresses. These facilities may also be furnished to replace identical facilities for maintenance reasons.

2. Charges

**B. DIAL DICTATION ARRANGEMENTS**

1. General

Where now furnished these arrangements may be retained by existing customers at their present addresses. These facilities may also be furnished to replace identical facilities for maintenance reasons.

2. Dial Dictation Trunk Equipment for use with both dial controlled and voice controlled customer-provided dictation machines:

a. Class B Dial Dictation Trunk Equipment (not located in PBX equipment cabinet or room or customer-provided dictation recording machine is not located in same building as PBX equipment cabinet or room), each	DCE	\$41.03	\$39.34	\$655.56

b. Initial Contract Period and Termination Charges  
The initial contract period for Dial Dictation Trunk Equipment is five years, starting with the date service is established. In the event of discontinuance of a Dial Dictation Trunk equipment prior to the expiration of the initial contract period, termination charges are applicable. The Termination Charge Base reduces 1/60 for each month of service.

c. Moves and Rearrangements  
For the move or rearrangement of a Dial Dictation Trunk Equipment in the same building, a nonrecurring charge of \$16.39 applies. For the move or rearrangement of a Dial Dictation Trunk Equipment to another building (same address), a nonrecurring charge of \$41.03 applies.
