**A. General**

The following services may be retained at the rates shown below under the conditions specified herein under "grandfathering":

1. Existing rotary business service has been grandfathered.
2. Existing one-Party rotary residence service has been grandfathered.
3. Existing two-party residence service has been grandfathered. Two-party service will not be available as a service offering effective December 31, 1996. In offices converted that are scheduled for conversion to digital switching technology, existing two-party service is no longer available. Customers are changed to one-party service at the time of the conversion, and charged the applicable one party access line rate.
