The Complete Choice Basic nonrecurring charge will not apply if the customer changes or adds features as long as the customer maintains the Complete Choice Basic on the same line. The Complete Choice Basic nonrecurring charge is a line-level charge. The Complete Choice Basic nonrecurring package charge will apply to each additional access line.
- 10. Nonrecurring charges, except as shown in D. will not apply when existing customers add the package. Nonrecurring charges may apply to the installation of new Access Lines.
