A. DESCRIPTION

- a. Centrex service is provided from central office switching equipment located on a premises owned or leased by the Company and connected by local loops to the premises of the customer or an authorized user.
- b. Centrex service is provided from analog electronic central office switching equipment such as No. 1, No. 1A or No. 2 ESS or from digital electronic central office switching equipment such as DMS 100 or No. 5 ESS.
- c. Centrex enables station users to dial intra-system and outgoing calls directly. Incoming calls may be dialed directly to any station. Incoming calls to the main listed number for the service are connected to a designated answering point and then may be transferred to the desired party.
- d. The Centrex station line includes a local loop (which includes dial tone and a telephone number) and the unregulated basic features package. Unregulated Optional features and services are available.
- e. Centrex is offered only where the customer's location is served by central office switching equipment which has available the equipment and the capacity to provide the service.
- f. Centrex is offered only as a complete service. The local loop is not provided without unregulated basic features or vice versa.
- g. Centrex is offered for a minimum period of one month. Centrex is also available under optional Term Payment Plans of up to and including 84 months.

1. Classes of Service

- a. Business Measured Service - those station lines that serve the premises of business customers including college or university administrative functions, such as office and classroom buildings, faculty clubs, student unions, or administrative quarters of dormitories. Where service in dormitories or other residence locations is provided for instructional purposes as part of the educational process (e.g., for communications with computer assisted education systems) and is not normally used for social or domestic purposes, business service is provided. Business Measured Rate message charge as specified in Part 4, Section 2 apply for local usage.
- b. Residence Flat Rate (Dormitory) - those station lines that serve the living quarters of a college, university or hospital (dormitories, apartments, etc.) and where the major use is of a social or domestic nature by students, faculty members or employees.

2. Intercept of Calls to Unassigned Station Line Numbers

Incoming and Intragroup calls to unassigned numbers are intercepted by a standard recorded announcement.

4. Centrex Service Guarantee (cont'd)

- f. Customers electing the Centrex Service Guarantee may make changes to their Centrex service (station additions, feature changes and additions, etc.) subject to the sub-paragraph above; however, the 90 day initial period applicable to the additions or changes shall begin from the date of installation of the original Centrex service.
- g. Customers may select 36^{/1/}, 60^{/1/} or 84^{/1/} month service plans. Month-to-month service plans are not available. However, if the customer terminates the service before expiration of the initial 90 days, the month-to-month rate shall apply for that period. (C)
- h. Except as otherwise provided in this sub-paragraph, rates, charges, term and conditions as specified elsewhere in this Guidebook for Centrex shall apply as applicable.
- i. Centrex Service Guarantee is limited to customers with 2 - 100 lines.
- j. Centrex Service Guarantee is not available to temporary service customers.

The following prices are applicable to standard installations of Centrex Service and are in addition to all other charges for associated services and equipment necessary to provide telecommunications service.

The total charge per Primary Station is the sum of the appropriate Network Access and Intercommunication charges (Basic lines, Electronic Key lines, ISDN Custom and National lines.)

When the customer's premises and the central office providing Centrex Service are located in different Service Areas, Base Rate, DS1 or DS3 Service charges will apply. (See Other Applicable Charges). Customers provided this service arrangement will require Channel Mileage (CM) and Channel Mileage Terminations (CMT) for each Centrex line. For ISDN Centrex lines having this service arrangement, three Channel Mileage (CM) and six Channel Mileage Terminations (CMT) are applicable when using Ameritech Base Rate.

Refer to the Other Applicable Charges section for additional charges associated with the provision of Centrex Service.

System Charge

The System Charge is applicable to the establishment of any new Centrex system and to any relocation of an entire Centrex system, unless the customer's relocation is within the serving central office boundary. The System Charge will be determined at time of installation based on the total number of equipped telephone numbers. A System Charge applies to each Centrex Service arrangement or common block.
