E1. APPLICATION OF TARIFF**E1.1 General**

- A.** This Tariff contains regulations, rates and charges applicable to the provision of Carrier Common Line, BellSouth SWA, and other miscellaneous services, except for Section E8. which addresses Payphone Service Providers (PSPs) and clearinghouse agents who are authorized to act as agents for certified Interexchange Carriers which could be both InterLATA and IntraLATA, and Section E17. which addresses Cellular Mobile Carriers (CMCs) who are authorized to provide Wide Area Call Reception Service, hereinafter referred to as service(s), provided by BellSouth Telecommunications, Inc.1, hereinafter referred to as the Company, to Interexchange Carriers, and Local Exchange Companies, Payphone Service Providers, and clearinghouse agents as discussed in Section E8. hereinafter referred to as IC(s) and Cellular Mobile Carriers as discussed in specific circumstances as described in E6.1.A. to end users. (C)
- The services identified in this Tariff, with certain exceptions which are identified as follows, are also available to other customers, subject to the same constraints and limitations that are applicable to certified interexchange carriers.
1. Automatic Number/Charge Number Identification;
 2. BellSouth SWA FGD service with BellSouth SWA CCSAC (and related options);
 3. Billing and Collection Services; and
 4. BellSouth Billing Name and Address for ANI.
 5. BellSouth SWA Common Transport IP Option
- B.** The provision of such services by the Company as set forth in this Tariff does not constitute a joint undertaking with the IC for the furnishing of any service.
- C.** The regulations, rates, and charges contained herein are in addition to the applicable regulations, rates, and charges specified in other tariffs of the Company which are referenced herein.
- D.** The regulations, rates and charges contained within this Tariff are not applicable to Radio Common Carriers, except for those CMCs who receive additional authority (certification) from the North Carolina Utilities Commission to provide Wide Area Call Reception Service for interCGSA traffic. The regulations, rates and charges for Wide Area Call Reception Service are contained in Section E17. of this Tariff.
- E.** The Company code for North Carolina is 5193.

Note 1: Wherever in this Tariff the name Southern Bell Telephone and Telegraph Company or the term "Company" appears, that shall mean and shall refer to BellSouth Telecommunications, Inc.
