N18. INTRALATA LONG DISTANCE SERVICE

N18.1 IntraLATA Long Distance

N18.1.1 General

- A. IntraLATA long distance provides call completion between two or more points which are located in the same Local Access Transport Area (LATA) within the State of North Carolina where the respective rate centers of such points also are located in said State.

N18.1.2 Rates and Charges

A. Rate Tables

Rates shown in the following table are applicable to intraLATA intrastate messages between all points within the same LATA and within the state.

- b. Customer Dialed Calling Card rates apply to station-to-station calls where the person originating the call dials and completes the call without the assistance of an operator. This rate will also apply when operator assistance is used to record the Calling Card number, or where the operator reaches the called telephone number where facilities are not available for Customer Dial (0+) completion. If facilities are available for Customer Dialed (0+) completion and the operator is used for completion of the call as well as for recording the Calling Card number, the "All other" operator station-to-station rate will apply instead of the Customer Dialed Calling Card rate.
- c. Person-to-person rates apply where the person originating the call specifies to the operator a particular person to be reached, a particular mobile station to be reached through a Miscellaneous Common Carrier attendant, or a particular station, department, or office to be reached through a PBX or Centrex Type Services attendant.
