- B. Expiration of Rate Stability Plan Period
  - 1. BellSouth Centrex service subscribers may upon the expiration of their contract choose either a. or b.
    - a. Enter into a new contract mutually agreeable to the Customer and the Company. If Customer enters a new contract with a Rate Stability Plan of 24 months or greater, Company shall waive one month of the Common Equipment rate for each year of the new Rate Stability Plan period. This waiver does not apply to conversions of other services to BellSouth Centrex service; or
    - b. Accept service on a month-to-month basis, at the rates shown below. If the customer makes no election, the Company will continue to provide service on a month-to-month basis, at the rates shown below.
