PURPOSE: BellSouth Telecommunications, LLC d/b/a AT&T North Carolina intends to retire copper facilities in distribution areas (DA) 310904 and 310906 of Raleigh wire center (RLGHNCSD), due to the impact of a planned North Carolina Department of Transportation (NCDOT) road move at Six Forks Road. NCDOT has requested AT&T North Carolina remove or relocate its facilities in the way of this road project before 2023. AT&T North Carolina plans to migrate copper facilities customers to existing Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) facilities and retire the copper facilities.
