North Carolina Department of Transportation (NCDOT) has requested AT&T North Carolina remove or relocate its facilities in the way of this road project before April 30, 2024.s to existing Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) facilities and retire the copper facilities.
