This road construction will improve Kildaire Farm Road and Shirley Dr., and NCDOT has requested AT&T North Carolina remove or relocate its facilities in the way of this road project before June 15, 2024.olina plans to migrate copper facilities customers to existing Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) facilities and retire the copper facilities.
