GENERAL SUBSCRIBER SERVICE TARIFF FOR THE STATE OF NORTH CAROLINA

This Tariff contains regulations and rates applicable for the furnishing of specified general subscriber services offered by BellSouth Telecommunications, LLC within this State.¹ This Tariff and a Map Supplement containing individual Exchange Service Area Maps are on file with the North Carolina Utilities Commission.

Communication services described in this Tariff are furnished through facilities provided by the Company for the transmission of intelligence by electrical impulse, principally by means of wire, radio or a combination thereof.

The rates, terms and conditions listed in the Tariff are applicable for services provided pursuant to this tariff. When services are not provided pursuant to a filed tariff, the rates, terms and conditions shall be offered pursuant to a Services Agreement contract. The agreements are provided at att.com/servicepublications. Guidebooks can also be found via this link.

The Company may discontinue certain Company services in geographic areas for which the Company has no customers subscribing to those services.

The Company may grandfather Company services in certain geographic areas at its discretion, subject to any applicable regulatory approvals. All services described in this Guidebook will no longer be available for purchase by new or existing customers in certain geographic areas in South Carolina. In addition, requests to move, add or change existing service will not be accepted. Existing customers may cancel local features on their existing service.
