PURPOSE: BellSouth Telecommunications, LLC d/b/a AT&T North Carolina intends to retire copper facilities in distribution area (DA) 330404 of the Garner wire center (RLGHNCGA). A car accident severely damaged a x-box causing degradation of copper facilities in nearby cabinets serving DA with temporization. After implementation of this plan, copper facilities, and consequently unbundled loops requiring copper facilities, e.g., digital subscriber line (DSL) or line-sharing circuits will no longer be available in DA 330404. records indicate (27) working circuits, and no competitive carrier circuits impacted by this network change. Existing customers will be migrated to Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) without consequence,
