N1.1 Inside Wire - Basic Residence and Basic Business Services

N1.1.1 General

- A. Inside Wire is all telecommunications wire and associated material that is located on the customer's side of the network interface, on the same premises.
- B. Basic Residence and Business service, as specified herein, is defined as individual local exchange service which does not terminate in a communications system.

N1.1.2 Rates and Charges

- A. Basic Residence and Basic Business services
 - 1. Flat Rate Charges Installation and Maintenance

The following charges are for labor, wiring and miscellaneous material and do not include other material costs (e.g. jacks, separate unit entrance bridges) unless specified. These charges exclude all work operations requiring more than two hours for completion and/or any work operation specifically classified as extraordinary, including but not limited to the following: installing, repairing or replacing a jack/wire in a boat, RV or travel trailer; installing, repairing or replacing a jack/wire or rearranging a wire when required to drill through steel, concrete or fire walls; and rearrangement of multiple inside wires due to movement of the network interface or protector.
