4.2.2 LOCAL EXCHANGE SERVICE

A. LOCAL EXCHANGE SERVICE (GENERAL)

1. DESCRIPTION

Local Exchange Service provides access to the exchange system of the Company and consists of a termination of the subscriber's premises connected to a line to the central office serving the area in which the subscriber is located. Connection at the central office to switching equipment permits communication with other telephone users.

Tariffs located in Part 4, Section 2 of this Guidebook set forth the availability of, and rates for, the types and grades of local exchange service.

2. REGULATIONS

The Reno Exchange consists of the following wire centers: RENONV02, RENONV12, RENONV13, RENONV14, RENONV15, SNVYNV11, SPRKNV11, SPRKNV12, STEDNV11, LCWDNV11, WASONV11 and VERDNV11.

The Company's Parts 1, 2, 3, 4 and 8 are incorporated by reference as applicable to the provisioning of the services herein.

Federal Communications Commission (FCC) regulations, rates, and charges are applicable as specified in Tariff FCC No. 1 to the services herein.

4.2.2.1.1 LOCAL EXCHANGE MEASURED RATE SERVICE

A. DESCRIPTION

- 1. Exchange measured service consists of measured business service and measured trunks. (C)
- 2. Measured Service usage refers to charges for local usage on the basis of (1) the number of completed calls, (2) duration or length of conversation in minutes, and (3) time of day and day of week.
- 3. A base rate area is a more closely built up section of the exchange area in which the base rates apply.
- 4. A special rate area is an outlying section of an exchange within which special rate treatment may be applicable.

B. REGULATIONS

- 1. These rates apply within the base rate area or special rate area of a listed exchange. The rate for individual access line business and residence service does not extend beyond the point of demarcation.
- 2. Exchange measured business service is offered statewide in all exchanges as facilities of the serving central office and operation conditions permit. (C)

B. REGULATIONS (Cont'd)

4. Measured business line service will be provided in accordance with the following:
 - a. At rates and charges equivalent to other business service furnished to the same customer on the same premises.
 - b. The service is furnished:
 - only for operator assisted outgoing toll calls placed from stations connected to the line (USOC TXX), or
 - to allow both incoming and outgoing local and toll calls, with time and charge information reported on all operator assisted set-paid call (USOC TWX).

5. Operator Assisted Service

Dial Station Message Toll Charges for the lowest step (0-10 miles) plus the appropriate Operator Service Charge, as set forth in Part 9, Section 1, apply to local calls placed with the assistance of a Company operator.

6. A combination of flat rate and measured rate business or residence access line service will not be furnished concurrently on the same premises when service is furnished from the same exchange.

A. DESCRIPTION

A base rate area is a more closely built up section of the exchange area in which the base rates apply without mileage charges.

A special rate area is an outlying section of an exchange within which special rate treatment is applicable without suburban mileage charges.

B. REGULATIONS

1. These rates apply within the base rate area or special rate area of a listed exchange. The rate for an individual access line business and residence service does not extend beyond the point of demarcation.
2. Rates shown in C.1 following are for flat rate service unless otherwise specified.

Rates for service, other than extended service, comprehend local service without additional charge to all stations receiving service from the exchange from which the primary station is served.

Rates for Ely extended service comprehend service without additional charge to all stations receiving service from the Ely and McGill exchanges.

Rates for McGill extended service comprehend service without additional charge to all stations receiving service from the Ely and McGill exchanges.

Rates for Carson City/Dayton extended service comprehend service without additional charges to all stations receiving service from the Carson City/Dayton, Reno/Sparks, Crystal Bay, Virginia City, Carson Plains, Stagecoach and Silver Springs exchanges.

Rates for Carson City, excluding Dayton, also comprehend service without additional charge to stations receiving service from the Contel of Nevada Gardnerville exchanges.

Rates for Reno/Sparks extended service comprehend service without additional charge to all stations receiving service from the Reno/Sparks, Carson City/Dayton, Crystal Bay, Virginia City, and Verdi, California exchanges.

Rates for Reno/Sparks, excluding Washoe Valley and Verdi, Nevada, also comprehend service without additional charge to all stations receiving service from the Fernley/Wadsworth, Nixon, Sutcliffe and Cottonwood Creek exchanges.

Rates for Virginia City extended service comprehend service without additional charge to all stations receiving service from the Virginia City, Carson City/Dayton, Crystal Bay and Reno/Sparks exchanges.

Rates for Fernley/Wadsworth extended service comprehend service without additional charge to all stations receiving service from the Fernley/Wadsworth, Nixon, Sutcliffe, Cottonwood Creek, Silver Springs and Reno/Sparks exchanges, excluding Washoe Valley and Verdi, Nevada.

Rates for Nixon extended service comprehend service without additional charge to all stations receiving service from the Nixon, Fernley/Wadsworth, Sutcliffe, Cottonwood Creek and Reno/Sparks exchanges, excluding Washoe Valley and Verdi, Nevada.

Rates for Sutcliffe extended service comprehend service without additional charge to all stations receiving service from the Sutcliffe, Fernley/Wadsworth, Nixon, Cottonwood Creek and Reno/Sparks exchanges, excluding Washoe Valley and Verdi, Nevada.

Rates for Cottonwood Creek extended service comprehend service without additional charge to all stations receiving service from the Cottonwood Creek, Fernley/Wadsworth, Nixon, Sutcliffe and Reno/Sparks exchanges, excluding Washoe Valley and Verdi, Nevada.

Rates for Gardnerville exchange extended service comprehend service without additional charge to all stations receiving service from the Gardnerville exchange, including the areas of Johnson Lane, Gardnerville, Gardnerville Ranchos, Minden and Genoa as legally described by Contel of Nevada, and from the Carson City exchange, excluding Dayton.

Business and Residence Individual Flat Rate service under this tariff will be provided outside the exchange area to a non-contiguous exchange, toll region or to unfilled territory in accordance with Rates and Conditions in Part 15, Section 2 Mileage rates.

The toll rates applicable to toll service in connection with foreign exchange service will be in accordance with the toll tariff provisions of the foreign exchange.

 - a. At rates and charges equivalent to other business service furnished to the same customer on the same premises.

A. DESCRIPTION

Suburban mileage charges are applicable to basic exchange service for customers who reside outside of the base rate area or special rate area within an exchange.

B. REGULATIONS

1. Mileage rates apply when the customer's premises is located outside the base rate area or special rate area and within the exchange area and is in addition to all other rates applicable to those services.
2. Mileage rates are based on air-line distance measured between the customer's premises and the nearest point on the boundary of the base rate area or special rate area.
3. Suburban mileage rates in the local exchange apply in addition to the foreign exchange channel mileage rate as shown in Part 15, Section 2 of this Guidebook, if the customer's primary service is located outside the base rate area or special rate area.

4.2.3 PRIVATE BRANCH EXCHANGE TRUNKS

A. DESCRIPTION

Private Branch Exchange (PBX) trunk lines provide a telecommunications channel between the customer's premises and the Company's central office (CO). The channel connects PBX stations to the telecommunications network.

B. REGULATIONS

1. PBX service will be provided outside the base rate area or special rate area and within the exchange area at the rates listed in this tariff.
2. Service under this Guidebook will be provided outside the exchange area according to rates and regulations listed in Part 15, Section 2 of this Guidebook, or Part 4, Section 5 of this Guidebook for Mileage Charges.
3. The toll rates applicable to toll service in connection with foreign exchange service will be according to the toll tariff provisions of the foreign exchange.
4. Lines and/or stations are installed on the premises on which the PBX switchboard or subsidiary PBX is located. Rates as specified in Part 4, Section 5 apply to off-premises mileage.

5. Interior Wiring

a. Where local facilities and operating conditions permit, trunk lines will be provided in accordance with the following:

b. The service is furnished:

(1) only for operator assisted outgoing toll calls placed from stations of a PBX (USOC T86 or THBHD);

(2) to allow only outgoing local and toll calls, with time and charge information reported on all operator assisted sent-paid calls (USOC TTTXA, TTTXB); and

(3) to allow both incoming and outgoing local and toll calls, with time and charge information reported on all operator assisted sent-paid calls (USOC TWB).

4.2.3.1 MEASURED RATE TRUNKS

A. REGULATION

1. Measured trunks will be offered statewide where facilities and operating conditions permit.
2. 4-wire trunks will be available upon customer request. Rates for these trunks will be double the standard 2-wire trunk rate. Installation/service connection rates will also be doubled.

4.2.3.2.1 TERM AND VOLUME DISCOUNT PLAN (TVD)

A. Description

An optional discount pricing plan providing for term pricing on 1 or more measured or flat-rate private branch exchange PBX trunk lines, with additional discounts available for volume commitments. TVD provides for discount on 12, 24 and 36-month term commitments and volume commitments starting with a minimum of 1 PBX trunk line.

B. Regulations

1. Discounts are applied to currently applicable tariff rates.
2. Customer must commit to a minimum volume of PBX trunk lines. The total number of PBX trunk lines within the Company's territory will apply toward the volume commitment. At any time during the term, if the total number of PBX trunk lines in the Company's territory is less than the minimum, an adjustment charge will be billed to the customer.
3. Customer must sign a written service agreement establishing their commitment to the term period, volume, discount percentage to be applied to the monthly rate.
4. When a TVD customer moves service from one service location to another, the duration and discount associated with the service agreement is not affected. If the applicable local exchange access monthly rate changes as a result of the move, the monthly rate at the new service location will be based on the tariff rate in effect at the time of the move for the new location.
5. Customers requesting the termination of their service agreement prior to the completion of the term excluding moves, upgrades and renewals, will incur an early termination charge.
6. Early termination charges will not be billed if the customer upgrades to another one of the Company's services under a service agreement which term period is equal to or greater than the term period remaining on the service agreement being terminated.

At the time a customer subscribed to TVD, applicable non-recurring charges (NRCs) will be waived for existing customers migrating existing lines to the TVD plan, existing customers that add lines, and for customer coming to the Company from other carriers. Standard NRCs will apply to lines added subsequent to the initial order.

A. DESCRIPTION

Applies to extension service to business and residence individual service.

Extension station service provides the capability of originating or receiving calls from locations equipped with instruments in addition to the location of the main station.

A. DESCRIPTION

2. The service will be offered at no charge as part of the basic exchange rate, for all classes of service, as facilities become available throughout the territory served and as operating conditions permit.

B. REGULATIONS

1. The service requires special central office equipment and is provided only from central office with these facilities.
2. One or more stations associated with a line arranged for Touch-Tone Calling Service may remain equipped with rotary dials.
