12.1.1 LISTING SERVICES

A. DESCRIPTION

The rates and regulations for listings in this section apply only to the alphabetical listings containing the regular alphabetical list of names of customers and joint users in the Company's Listing Information System.

B. REGULATIONS

1. Additional Listings and Lines of Information

- a. Duplicate listings for a subscriber whose name may be arranged or spelled in more than one way may be provided upon request of the subscriber at the additional listing rate.
- b. All applications for additional listings and lines of information shall be made by the subscriber.
- c. A school, college or university which subscribes to Centrex Service may, for the residence additional listing rate, arrange for a residence additional listing in the name of a student, faculty member or other employee residing in living quarters which are owned or leased and operated by the school, college or university.

- d. The Business Customer assumes full responsibility concerning the right to use the telephone number and the Company does not undertake to determine the Customer's legal, contractual or other right to use the telephone number. Business Customer will indemnify, defend, and hold harmless Company from any claims, lawsuits, costs, damages, judgments, liabilities, losses or expenses, including reasonable attorney fees, that arise from Business Customer not having the right to use the telephone number, not complying with applicable law and regulations, or misleading or deceiving the public in any manner.

B. REGULATIONS (Cont'd)

3. Non-Published Listing Service

a. Non-published telephone numbers are not listed in the Company's Listing Information System, including the directory assistance records available to the general public. However, when a call is placed from a telephone number associated with a non-published listing, the number may be disclosed if the called party has the necessary service and equipment for receiving and/or disclosing incoming telephone numbers. (C)

b. Non-published service will be furnished, at the rates indicated in C.3 below to subscribers who request that their telephone numbers not be published in the Company's Listing Information System, except: (C)

Subscribers who have their primary telephone number listed in the Company's Listing Information System, may have other telephone numbers associated with the same business or residence, deleted from the Company's Listing Information System at no additional charge. (C)

1. Primary Service Listings:

One listing, without charge, termed the primary listing, is provided as follows: (C)

- Each individual line or party line primary station----- One listing
- Each answering line service ----- One listing
- Each joint user service ----- One listing
- Each private branch exchange or Centrex system -----One listing
- Each cord-operated telephone answering system ----- One listing
- Each intercommunication system -----One listing
- Each order receiving equipment system or Horizon  
Communication System, not operated as auxiliary  
To a private branch exchange or Centrex system -----One listing
