Upon expiration of the extension and for existing customers who do not extend an existing non-expired term plan agreement, service will continue on a month-to-month basis at the same rates in effect for such service immediately prior to such expiration, until the service is discontinued on at least 30 days prior notice by the customer or on at least 30 days notice (or such longer period as may be required by the Commission) by the Company. During such month-to-month period, the Company may change the rates, terms and conditions applicable to the customer's service upon at least 30 days written notice to the customer. Effective September 30, 2011 early termination charges shall not apply to any PremierSERVsm Asynchronous Transfer Mode (ATM) and PremierSERVsm Frame Relay services defined in the Advanced Services Guidebook.
