15.1 AT&T Mexico Value Calling 250<sup>/1/</sup>

- A. This plan is an add-on pricing option (i.e. it is used in addition to a domestic optional calling plan).
- B. Residential Customers subscribing to this Service will be subject to the following:
  - calls terminating to a wireless device, such as a cellular phone, pager, personal computer or personal digital assistant, a special service or a portable telephone number may incur additional per minute charge, referred to as international mobile termination charge as described in Section 9 of this Guidebook;
  - this plan is established at the BTN level and may not be combined with any other international plan.
- C. All calls are billed in one (1) minute increments, subject to a minimum connect time (initial period) of one (1) minute.
- D. For an MRC, the Customer receives a 250 minute BOT for placing (1) one plus (1+) Direct-Dialed International calls originating in the United States or Extended Area from a Customer's presubscribed line and terminate to Mexico. All usage in excess of the 250 minute BOT will be billed at a fixed rate per minute as defined in Grandfathered Plans - Section 15 A. of this Guidebook. The Customer may only subscribe to one BOT per BTN. Any minutes not used in a billing cycle will not be carried over to the next billing cycle. No credits will be given for any unused minutes.

15.1 AT&T Mexico Value Calling<sup>/1/</sup>

- A. This plan is an add-on pricing option offered in conjunction with a domestic optional calling plan available to residential customers located in California and Nevada. This plan is established at the BTN level and may not be combined with any other international plan.
- B. All calls are billed in one (1) minute increments, subject to a minimum connect time (initial period) of one (1) minute.

For a MRC, the Customer receives a 500 minute BOT for placing (1) one plus (1+) Direct-Dialed International calls originating in the United States or Extended Area from a Customer's presubscribed line and terminate to Mexico. All usage in excess of the 500 minute BOT will be billed at a fixed rate per minute as defined in Section 15 A. of this Guidebook. The Customer may only subscribe to one BOT per BTN. Any minutes not used in a billing cycle will not be carried over to the next billing cycle. No credits will be given for any unused minutes.

- C. Calls terminating to a wireless device, such as a cellular phone, pager, personal computer or personal digital assistant, a special service or a portable telephone number may incur additional per minute charge international mobile termination charge.
- D. Rates and Charges

The MRC is \$7.99 and \$0.05 per minute for all usage, to all Mexico locations, Mexico Zones 1 and 2 of Direct Dialed calling. See Section 15.10.A. of this Guidebook for per minute usage rates for calls to countries not included in this plan.

15.2 AsiaSaver Value Plan<sup>/1/</sup>

- A. This plan is an outbound only block of time long distance add-on pricing option (i.e. it is used in addition to the outbound interstate optional calling plan). This plan is available to Residential Customers that subscribe to any of the Company's outbound interstate optional calling plans.
- B. Calls terminating to a wireless device, such as a cellular phone, pager, personal computer or personal digital assistant may incur an additional per minute charge, referred to as an international mobile termination charge described in Section 9 of this Guidebook.
- C. All calls are billed in one (1) minute increments, subject to a minimum connect time (initial period) of one (1) minute.
- D. For an MRC, the Customer receives a ninety (60) minute block of time for placing outbound ~~for~~ 1+ Direct-Dialed International calls originating in the United States or Extended Area from a Customer's presubscribed line and terminate to China, Hong Kong, India, Japan, Malaysia, Pakistan, Philippines, Singapore, South Korea and Taiwan. All usage in excess of the sixty (60) minute block of time will be billed at a fixed rate per minute. Any minutes not used in a billing cycle will not be carried over to the next billing cycle. No credits will be given for any unused minutes.
- E. Customers may place calls to other countries not included in the block of time. See Section 15 B. for the countries per minute rates.
- F. Rates and Charges

The MRC is \$13.99 per BTN and the per-minute usage rate is \$0.17 for all usage in excess of minute block of time to countries included in this plan. See Section 15.10.B. for per minute usage rates for calls to countries not included in this plan.

- A. This plan is an outbound only block of time long distance add-on pricing option (i.e. it is used in addition to the outbound interstate optional calling plan).
- B. Calls terminating to a wireless device, such as a cellular phone, pager, personal computer or personal digital assistant may incur an additional per minute charge, referred to as international mobile termination charge described in Section 9 of this Guidebook.
- C. All calls are billed in one (1) minute increments, subject to a minimum connect time (initial period) of one (1) minute.
- D. For an MRC, the Customer receives a one-hundred-fifty (150) minute block of time for placing for 1+ Direct-Dialed International calls originating in the United States or Extended Area from a Customer's presubscribed line and terminate to the countries listed as "IN BLOCK" in Section 15 B. of this Guidebook. All usage in excess of the block of time will be billed at a fixed rate per minute as defined in Section 15 B. of this Guidebook. Any minutes not used in a billing cycle will not be carried over to the next billing cycle. No credits will be given for any unused minutes.
- E. The block of time selected at the time the Customer's order is processed will remain in effect until canceled or changed by the Customer.

15.5 JustCall Value Plan<sup>/1/</sup>

- A. This plan is an outbound only block of time long distance add-on pricing option (i.e. it is used in addition to an outbound bundled interstate/intrastate long distance optional calling plan).
- B. Calls terminating to a wireless device, such as a cellular phone, pager, personal computer or personal digital assistant, a special services or a portable telephone number may incur an additional per minute charge, referred to as an international mobile termination charge described in Section 9 of this Guidebook.
- C. All calls are billed in one (1) minute increments, subject to a minimum connect time (initial period) of one (1) minute.
- D. For an MRC, the Customer receives a three thousand (3000) minute BOT for placing (1) one plus (1+) Direct-Dialed International calls originating in the United States or Extended Area from a Customer's presubscribed line. All usage in excess of the three thousand (3000) minute BOT will be billed at a fixed rate per minute. Any minutes not used in a billing cycle will not be carried over to the next billing cycle. No credits will be given for any unused minutes. The Customer may only subscribe to one BOT per BTN. See Section 15 B. for rates and charges.
- E. The block of time selected at the time the Customer's order is processed will remain in effect until cancelled or changed by the Customer.
- F. If Customer cancels this plan and/or the required Unlimited Domestic plan, the Customer may select another optional international plan and/or domestic plan for which they qualify.

15.6 AT&T Worldwide & US Calling<sup>/1/</sup>

- A. AT&T Worldwide & US Calling is an outbound International long distance optional calling plan. AT&T Worldwide & US Calling applies only to 1+ Direct-Dialed International calls originating in the United States or Extended Area from a Customer's presubscribed line and terminating to an International number. For an MRC, Residential Customers who subscribe to AT&T Worldwide & US Calling will receive an AT&T Worldwide & US Calling per minute rate as described in Section 15 C. of this Guidebook. This plan may not be combined with any other International or Domestic Optional Calling plan. This plan is established at the BTN level.
- B. Except for International calls to Canada or the Caribbean Countries, Customers may direct dial International long distance calls by dialing 011 + country code + city code + number. Calls to Canada or Caribbean Countries are completed by dialing one (1) + area code + called telephone number.
- C. All calls are billed in increments of one (1) minute subject to a minimum connect time (initial period) of one (1) minute.
- D. Calls terminating to a wireless device, such as a cellular phone, pager, personal computer or personal digital assistant may incur an additional per minute charge, referred to as an international mobile termination charge described in Section 9 of this Guidebook.
- E. If a Customer cancels the AT&T Worldwide & US Calling optional calling plan the Customer may select another optional international plan and/or domestic plan for which they qualify.
- F. Rates and Charges

AT&T Worldwide Calling is an outbound only, International long distance optional calling plan available to Residential Customers that subscribe to any of the Company's interstate outbound Service offerings and request to be provisioned under this optional International calling plan. AT&T Worldwide Calling applies only to outbound 1+ Direct-Dialed International calls originating in the United States or Extended Area from a Customer's presubscribed line and terminating to an International number.
- B. Except for International calls to Canada or the Caribbean Countries, Customers may direct dial International long distance calls by dialing 011 + country code + city code + number. Calls to Canada or Caribbean Countries are completed by dialing one (1) + area code + called telephone number.
- C. All calls are billed in increments of one (1) minute subject to a minimum connect time (initial period) of one (1) minute.
- D. Calls terminating to a wireless device, such as a cellular phone, pager, personal computer or personal digital assistant may incur an additional per minute charge, referred to as an international mobile termination charge described in Section 9 of this Guidebook.
- E. Rates and Charges

15.8 AT&T Unlimited Canada Calling Plus<sup>/1/</sup>

- A. This plan is an outbound only Service designed for Residential Customers with a single BTN. Multiple BTN Aggregation is not available with this Service. Customers or End Users can access the Company's long distance Service by dialing 1 + the area code + the called telephone number from their presubscribed telephone line. For a monthly recurring charge, the Customer receives unlimited international one plus (1+) Direct-Dialed minutes of use to Canada. All calls are billed in increments of one (1) minute subject to a minimum connect time (initial period) of one (1) minute. See Section 15.10 (D) of this Guidebook for rates.

Customers subscribing to this plan must:

- use Switched Access to reach the long distance network;
  - subscribe to and maintain the required Domestic Services, products, and/or features described in this Guidebook, selected by the Customer;
  - subscribe to and maintain this plan for the provision of (a) intrastate InterLATA Service and interstate service or (b) intrastate IntraLATA Service, intrastate InterLATA Service and interstate service (this Service is not available for intrastate Service on a stand-alone basis);
  - provide the Company the same billing name and address for all services required to subscribe to Unlimited Canada Calling Plus;
  - limit the use of Service to that which is of a standard residential nature; and
  - request to be provisioned under this Service.
- B. Customers who cancel or discontinue the Company's Service or any of the required Domestic products, services or features as described in this Guidebook or whose Service is refused, cancelled or discontinued by an Affiliated ILEC shall forfeit eligibility for rates under this Service. Customers continuing to presubscribe to the Company will be moved to the Residential Basic IDDD as referenced in Section 7.1 in this Guidebook, and the rates described in Section 7.1.2 of this Guidebook for Residential Basic IDDD will apply unless the Customer selects an alternative Plan or Service.
- C. If the Customer uses this Service for non-standard residential or non-residential purposes, including but not limited to commercial or broadcast facsimile, resale, telemarketing, internet connections and autodialing, the Company may immediately suspend, restrict or cancel the Customer's Service. As a result of non-standard or nonresidential use of Service, the Company may move the Customer to Residential Basic IDDD as referenced in Section 7.1 in this Guidebook and the rates and charges described in Section 7.1.2 Residential Basic IDDD will apply unless the Customer selects an alternative Plan or Service.
- E. Calls terminating to a wireless device, such as a cellular phone, pager, personal computer or personal digital assistant may incur an additional per minute charge, referred to as an international mobile termination charge described in Section 9 of this Guidebook.
- F. Rates and Charges

The MRC is \$6.99 per month. See Section 15.10.D. for per minute usage rates for calls to countries not included in this plan.

- A. AT&T Worldwide Occasional Calling Plan is an outbound International long distance optional calling plan available to Residential Customers that subscribe to and maintain an access line from an Affiliated ILEC, and any one of the Company's Residential domestic outbound optional calling plans as described in this Guidebook. AT&T Worldwide Occasional Calling Plan applies only to 1+ Direct-Dialed International calls originating in the United States or Extended Area from a Customer's presubscribed line and terminating to an International number. For an MRC Residential Customers who subscribe to AT&T Worldwide Occasional Calling Plan will receive an AT&T Worldwide Occasional Calling Plan per minute rate as described in Section 15.10 (D) of this Guidebook. This plan may not be combined with any other International Optional Calling plan. This plan is established at the BTN level.
- B. Except for International calls to Canada or the Caribbean Countries, Customers may direct dial International long distance calls by dialing 011 + country code + city code + number. Calls to Canada or Caribbean Countries are completed by dialing one (1) + area code + called telephone number.
- C. All calls are billed in increments of one (1) minute subject to a minimum connect time (initial period) of one (1) minute.
- D. Calls terminating to a wireless device, such as a cellular phone, pager, personal computer or personal digital assistant may incur an additional per minute charge, referred to as an international mobile termination charge described in Section 9.14 of this Guidebook.
- E. If a Customer cancels the AT&T Worldwide Occasional Calling Plan optional calling plan of this Guidebook, the Customer will be billed Residential Basic IDDD rates as referenced in Section 7.1.2 of this Guidebook and the rates described in Section 7.1.2 will apply unless the Customer selects an alternative Service.
- F. This plan provides discounted rates for direct-dialed calls from the US to International locations in the plan.
- \ G. Rates and Charges

The MRC is \$2.99 and includes outbound 1+ direct-dialed calls. See Section 15.10.D. for per minute usage rates associated with this plan.
