This move charge is equal to the sum of the Service Change and/or Inside Move Charge and the Premises Visit Charge as provided in paragraph J. A Move of Service charge also applies for each BellSouth Channelized Trunks 1.544 Mbps Access Line moved to a new location in Company territory within the same state. In this case the move charge is equal to the sum of all nonrecurring charges applicable to a new BellSouth Channelized Trunks 1.544 Mbps Access Line installation at the new location including a Premise Visit Charge.

J. Service Installation and Rearrangement

- C. Warm Line Service is furnished only from central offices which have been arranged to provide this service and is provided subject to the availability of facilities.
