All of the terms, conditions and limitations specified for each offering will apply to the respective services and features.
  - 6. Usage rating is dependent upon the underlying service of the originating call location. When BellSouth Business Plus service usage charges as described in paragraph 2 are applicable, they will also apply to 1+, 0+ and 0- calls made within the LATA.
