## SERVICE CONNECTIONS, MOVES AND CHANGES

## 1. General (cont'd)

- 1.7.5 A promotional period will be established from December 2, 2002 through December 1, 2003. During this promotional period, residential customers who subscribe to an access line, Caller ID Name and Number and Speed Call 8 will receive a waiver of all applicable installation charges.
- 1.7.6 A promotional period will be established from August 11, 2003 through August 10, 2004. During this promotional period, residential customers who subscribe to an access line and Caller ID Name and Number will receive a waiver of all applicable installation charges. To be eligible for this promotion, the customer must have discontinued their exchange access line with the Company for the purpose of establishing service with another carrier within the Company serving area and who now wish to return to the Company. Installation charges eligible for waiver do not include charges incurred as a result of a premise visit for installation of jacks and wiring.
- 1.7.7 A promotional period will be established from June 15, 2004 through August 10, 2004. During this promotional period, residential customers who subscribe to an access line and Caller ID Name and Number will receive a waiver of all applicable installation charges. To be eligible for this promotion, the customer must have their exchange access line with another carrier within the Company serving area and now wish to establish service with the Company. Installation charges eligible for waiver do not include charges incurred as a result of a premise visit for installation of jacks and wiring.
- 1.7.8 Residential customers who subscribe to an access line will receive a waiver of all applicable installation charges.

(C) (C) (D)

To be eligible for this offer, the customer must have their exchange access line with another carrier and now wish to establish service with the Company. Installation charges eligible for waiver do not include charges incurred as a result of a premise visit for installation of jacks and wiring. This waiver of charges may not be combined with a customer's receipt of a Link-Up discount.
