3.125 Paperless Bill Incentive Offer II

A business promotional period will be established from August 22, 2011 through December 31, 2014. During this period residential customers who receive an (C incentive offer and sign up for paperless billing online will be eligible to receive a \$10 Visa Reward. The customer must remain with paperless billing for 90 days in order to receive the reward.

Eligible customers are:

- Residential customers not currently subscribed to paperless billing,
- Residential customers who agree to receive their bill electronically in lieu of paper

3.126 \$10 AutoPay Incentive Promotion

A retail promotional period will be established from November 1, 2011 through December 31, 2014. During this period residential customers who receive an incentive offer either online or via email and currently use a one-time payment method and sign up for the automatic payment feature, AutoPay, will be eligible to receive a \$10 benefit in the form of a reward card. The customer must remain on AutoPay for 90 days in order to receive the reward card. Eligible customers are residential customers not currently registered for AutoPay.
