Re: Tariff filing of Southwestern Bell Telephone Company d/b/a AT&T Texas pursuant to PURA § 52.007(d-2)(1)

Attached for filing are the original and five copies of the following tariff sheets for Southwestern Bell Telephone Company d/b/a AT&T Texas. With this filing AT&T Texas is removing the FibreMan Service section from the tariff. The Public Utilities Commission of Texas previously approved the application of AT&T Texas to withdraw this service (Docket No. 38968). Customers were allowed to retain service through January 31, 2013, at which time all remaining circuits were discontinued. Notice of the service withdrawal had previously been provided to customers under the docket noted above. There are no subscribers at this time.
