

1. GENERAL**A. SCOPE**

1. This Guidebook applies to Long Distance Message Telecommunications Service furnished or made available by the Wisconsin Telephone Company hereinafter referred to as the Telephone Company - and its connecting companies over facilities wholly within or partly within and partly without the State of Wisconsin, between points, the rate centers of which are in the State of Wisconsin, and to Mobile Telephone Service under the provisions as set forth in this Guidebook. (C)
2. Long distance message telecommunications service is that of furnishing facilities by means of wire, radio or a combination thereof for telecommunications between stations in different local service areas in accordance with the regulations and systems of charges specified in this guidebook. The toll service charges specified are in payment for all service furnished between the calling and called telephones. (C)

B. REGULATIONS

1. Undertaking of Telephone Company
The Telephone Company does not undertake to transmit messages but offers the use of its facilities for communications between its customers. The design, maintenance and operation of Long Distance Message Telecommunications Service envisions that communications will originate or terminate at a station of the associated exchange telephone service used for LDMTS. Connections of Customer or Other Common Carrier-provided communications systems may be made to LDMTS. However, the Telephone Company will not be responsible for the through transmission of signals or for the quality or transmission on such connections.
2. Priority of Service
 - a. In case a shortage of facilities exists at any time either for temporary or protracted periods, the establishment of long distance message telecommunications service shall take precedence over all other interexchange services.
 - b. Service is furnished subject to the availability of the service components required. The Telephone Company will (1) determine which of those components shall be used and (2) make modifications to those components at its option.

2. Priority of Service (cont'd)

- c. When connections are made to Customer or Other Common Carrier-provided communications systems at a premises where the Customer does not originate or terminate communications, the Telephone Company may require that the exchange telephone service be furnished from a Telephone Company Central Office(s) different than the Central Office(s) designated by the Telephone Company to serve that premises.

3. Limited Conversation

The Company reserves the right to limit the length of conversation when necessary in time of emergency resulting in a shortage of facilities.

4. Billing and Payment arrangements

The regulations set forth in Part 2 Section 2, for Billing and Payment arrangements apply when appropriate.

The customer is responsible for payment of all Third Number Billed Calls made by the customer or other persons authorized by the customer^{/1/}. Users, once authorized, will continue to be authorized until the customer notifies the Telephone Company that they are no longer authorized. (C)

Unauthorized Third Number Billed Calls billed to the customer will be treated as an attempt by the person placing such unauthorized calls to obtain telephone service without payment.

/1/ Effective March 19, 2016, Collect, Person-to-Person, Bill to Third Number calls and Busy Line Verification/Interruption services are discontinued.

5. Obligation of Customer

(D)

a. The calling party (or customer) shall establish his identity in the course of any communication as often as may be necessary.

b. The calling party (or customer) shall be solely responsible for establishing the identity of the person or persons with whom connection is made at the called station.

6. Termination of Service

The regulations set forth in Part 2 Section 2, for Termination of Service apply when appropriate.

B. REGULATIONS (Cont'd)

8. Use of Service

a. Resale

The service is provided for use by the customer and may be used by others, when so authorized by the customer, providing that all such usage shall be subject to the provisions of this tariff.

b. Telephotographic Equipment

Telephotograph Equipment Provided by the Press, Law Enforcement Agencies, the Armed Forces, Civilian Defense Agencies and the United States Weather Bureau.

- (1) Long distance message telecommunications service is available for use by the Press for the transmission and reception of pictures and similar material for publication, for use by law enforcement agencies for the transmission and reception of fingerprints, ballistic data, identification photographs and similar material for law enforcement, for use by the armed forces of the United States for the transmission and reception of information of military necessity essential to the national defense and for use by civilian defense agencies for the transmission and reception of information essential for the discharge of their responsibilities in emergencies and for use by the United States Weather Bureau for the transmission and reception of weather information, by means of telephotograph equipment provided by the customer.
- (2) Connection of the telephotograph equipment shall be made to the facilities of the Telephone Company or its connecting companies as specified in Part 2 Section 9.
- (3) The operating characteristics of the telephotograph equipment shall be such as not to interfere with any of the services offered by the Telephone Company as specified in Part 2 Section 9.

8. Use of Service (Cont'd)

b. Telephotographic Equipment (Cont'd)

(4) Long distance message telecommunications service furnished by the Telephone Company is not represented as adapted to the telephotographic transmission of pictures, fingerprints, ballistic data, identification photographs or similar material, information of military necessity or civilian defense information or weather information. The use of such service by the Press, law enforcement agencies, the armed forces, civilian defense agencies and the United States Weather Bureau for telephotographic transmission is permitted only on the condition that the Telephone Company shall not be responsible to the customer for damages arising out of mistakes, omissions, interruptions, delays, or errors or defects in transmission, except those caused by its failure to furnish facilities suitable for ordinary telephone service or its failure to maintain and operate such facilities in a manner proper for telephone service. The liability of the Telephone Company for damages caused by its failure to furnish facilities suitable for ordinary telephone service or its failure to maintain and operate such facilities in a manner proper for telephone service is as set forth in C.

(5) The regulations and rates for each call made for the purpose of transmitting pictures are those applicable for long distance message telecommunications service, i.e., station-to-station, person-to-person, or conference, according to the connection established.

c. Connection with Customer-Provided Recording, Reproducing and Automatic Answering and Recording Equipment

Long distance message telecommunications service furnished by the Telephone Company is not represented as adapted to the recording of telephone conversations or incoming messages, or to the transmission or prerecorded messages. However, customer-provided recording, reproducing and automatic answering and recording equipment may be used in connection with long distance message telecommunications service for purposes, and subject to the conditions, rates and charges shown in Part 2 Section 9.

8. Use of Service (Cont'd)

d. Service used for "DATA-PHONE"® Transmission

- (1) Long distance message telecommunications service is available for use on a two point service basis with data transmitting and receiving equipment (includes tele-writer equipment) and tele-typewriter equipment for the transmission and reception of data signals.
- (2) Data transmitting and receiving equipment will be provided by the customer. Teletypewriter equipment may be provided by the customer or the Telephone Company, at the option of the customer.
- (3) The data transmitting and receiving equipment and teletypewriter equipment shall be connected to the facilities of the Telephone Company as specified in appropriate sections of this guidebook. (C)
- (4) The regulations and rates for each call made for the purpose of transmitting data signals are those applicable for long distance message telecommunications station-to-station services according to the connection established. (C)

e. Connections with Certain Facilities of Power, Pipe Line and Railroad Companies

Telephone facilities of an Electric Power Company or Oil, Oil Products or Natural Gas Pipe Line Company, or Railroad Company, provided primarily to communicate with points located along a right-of-way (including premises of such company anywhere in cities, towns or villages along the right-of-way) owned or controlled by such company, will be connected with long distance message telecommunications service furnished by the Telephone Company subject to the regulations and conditions stated in the tariff of this Company for connection of such facilities to Telephone Company local exchange and long distance telecommunications service and private line services and channels respectively.

8. Use of Service (Cont'd)

- f. **Connection of Customer-Provided Communications Systems and Terminal Equipment**
Customer-provided communications systems and terminal equipment may be used with the facilities furnished by the Telephone Company for long distance message telecommunications service as specified in the tariff of this company.
- g. **Connection With Communications Systems Provided By Other Common Carriers**
Communications systems provided by Other Common Carriers, as specified in the tariff of this company, may be used in connection with Long Distance Message Telecommunications service subject to the conditions specified in this Tariff.

C. LIABILITY OF TELEPHONE COMPANY

1. In view of the fact that the customer has exclusive control of his communications over the facilities furnished him by the Telephone Company and of his communications over the facilities furnished him by the Telephone Company and, because of unavoidability of errors incident to the services and to the use of such facilities of the Telephone Company, the services and facilities furnished by the Company are subject to the terms, conditions, and limitations specified in 2.,3. and 4. following.
2. The Telephone Company's liability, if any, for its willful misconduct is not limited by this tariff. With respect to any other claim or suit, by a customer or by any others, for damages associated with any aspect of the provision of service (including the failure to reach a called station), the Telephone Company's liability, if any, shall not exceed an amount equal to the initial period charge applicable for such a message to the called station. This liability shall be in addition to any billing adjustments that may otherwise be appropriate.

1. GENERAL (Cont'd)

C. LIABILITY OF TELEPHONE COMPANY (Cont'd)

3. When the lines of other telephone companies are used in establishing connections to points not reached by the Telephone Company's lines, the Telephone Company is not liable for any act or omission of the other company or companies.
4. The customer indemnifies and saves the Telephone Company harmless against claims for libel, slander, or infringement of copyright for the material transmitted over its facilities; against claims for infringement of patents arising from combining with, or using in connection with, facilities of the Telephone Company, apparatus and systems of the customer; and against all other claims arising out of any act or omission of the customer in connection with facilities provided by the Telephone Company.

2. STANDARD SERVICE OFFERINGS**2.1. TWO POINT MESSAGE TELECOMMUNICATION SERVICE****A. CHARGES DETERMINATION**

Service is offered on a Dial Station or Operator Assisted basis. Charges for messages within these classes of service are based on the day of the week and the time of the day at which connection is established.

B. CLASSES OF CALLS**1. Dial Station**

Dial Station rates apply only to sent paid, Station-to-Station dial type telephone communications.

Dial type telephone communication denotes a call dialed and completed by the customer from a residence or business telephone without the assistance of a Telephone Company operator. The services of a Telephone Company operator will not be used in connection with completing a call, or in furnishing any information or assistance relating to billing or charges for such call^{/1/}, except that a Telephone Company operator will:

2. STANDARD SERVICE OFFERINGS (cont'd)**2.1. TWO POINT MESSAGE TELECOMMUNICATION SERVICE (cont'd)****B. CLASSES OF CALLS (cont'd)****1. Dial Station (cont'd)**

- reestablish a call which has been interrupted after the called number has been reached or,
- place a call for a calling party who identifies himself as being handicapped and unable to dial the call because of his handicap or,
- reach the called telephone number where facilities are not available for customer dial completion.
- Dial Station rates do not apply on calls placed from a public or semi-public coin telephone.

2. Operator Assisted

Operator Assisted rates apply to all calls which are not classified as Dial Station, as specified in 1. preceding. This includes Person, Collect and Third Number Billed calls, as specified in Part 11, Section 1.

2. STANDARD SERVICE OFFERINGS (Cont'd)**2.1. TWO POINT MESSAGE TELECOMMUNICATION SERVICE (Cont'd)****C. TIMING OF CALLS**

The time when connection is established as provided in 2.1.C following, determined in accordance with the time - standard or daylight saving - legally or commonly in use at the location of the rate center of the calling party, determines whether Day, Evening or Night rates apply.

In cases where a message begins in one rate period and ends in another, the charge for the message will be computed in two parts. The initial period any additional minutes beginning in the first rate period will be charged for at the rates in effect in that period. Any additional minutes beginning in the second rate period will be charged for at the rates in effect in the second rate period.

1. On station-to-station calls, chargeable time begins when the connection is established between the calling telephone and the called telephone, regulated Miscellaneous Common Carrier mobile radio system, or PBX System.

2. Chargeable time does not include time lost because of failure or defects in the service.

3. Chargeable time ends when the calling station "hangs up" thereby releasing the network connection. If the called station "hangs up" but the calling station does not, chargeable time ends when the network connection is released either by automatic timing equipment in the telephone network or by the Telephone Company operator.

2. STANDARD SERVICE OFFERINGS (Cont'd)**2.1. TWO POINT MESSAGE TELECOMMUNICATION SERVICE (Cont'd)****C. TIMING OF CALLS (Cont'd)**

5. When exchange telephone service used for Long Distance Message Telecommunications Service is connected through a Service Terminating Arrangement or Connecting Arrangement (i.e., not connected through a Multiline Terminating System or Terminal Equipment) at a Customer's premises to a communications system, chargeable time for all classes of calls begins when a call from the telecommunications network terminates in or passes through the first multiline terminating system or terminal equipment on that communications system. (C)

D. VACANT**E. RATE AND CHARGE APPLICATION (Intrastate Service)**

1. Initial Period, Additional Minutes and Discounts
Rates are quoted in terms of initial periods and additional minutes.
 - a. Initial period rates given in the "Rate Tables" following are for connections of one minute or any fraction thereof.
 - b. All additional minute rates given in the "Rate Tables" following are for each additional minute or any fraction thereof that the connection continues beyond the initial period.

E. RATE AND CHARGE APPLICATION (IntraLATA Service) (cont'd)

1. Initial Period, Additional Minutes and Discounts (cont'd)

c. Discount rates if applicable for the Evening and Night reduced rate periods are specified in the "Rate Tables" that follow. These rates are applied to messages for which connections are established during the Evening and Night rate periods indicated in the "Rate Tables".

(1) The discount is applied to the sum of the initial period and additional minute charge determined from the "Rate Tables" following.

(2) Charges for Dial Station Intrastate Long Distance Message Telecommunications Service calls from certified deaf or speech disabled subscribers using teletypewriters from their residence service shall be discounted. Calls placed during the day, evening, and night rate periods will receive a 20% discount. This usage discount also applies to Third Number calls placed by certified deaf or speech disabled subscribers from their residence service or from Message Relay Centers (MRCs) on behalf of the certified deaf or speech disabled subscriber. In addition, the surcharge that would normally apply to Third Number calls will not apply in the case of the aforementioned operator handled calls. (C)

(3) When application of the discount results in a fractional charge, the amount will be rounded down to the lower cent. (C)

d. Rates Applicable on Certain Holidays

On Christmas Day (December 25) and on New Year's Day (January 1), Independence Day (July 4), Thanksgiving Day and Labor Day, the holiday rate applicable is the Evening rate, unless a lower rate would normally apply.

2. STANDARD SERVICE OFFERINGS (Cont'd)

E. RATE AND CHARGE APPLICATION (IntraLATA Service) (Cont'd)

1. Initial Period, Additional Minutes, and Discounts (Cont'd)

- e. Residence customers who select the Company as their intraLATA carrier will be provided with a Presubscription Change Charge credit per exchange access line, up to an annual maximum of nine credits per account. All residence customers are eligible to participate if they are not currently subscribed to the Company as the intraLATA carrier.
- f. Business customers that select the Company as their intraLATA toll carrier will be provided with a credit equal to the Presubscription change charge per exchange access line. Business customers that have nineteen or fewer exchange access lines may receive an annual maximum credit of up to 33 credits per account. Business customers that have twenty or more exchange access lines may receive an annual maximum credit of up to 100 credits per account. Customer participation is limited to three times per calendar year. All business customers are eligible to participate if they are not currently subscribed to the Company as the intraLATA carrier.

Credits associated with this promotion will be provided to business customers with nineteen or fewer exchange access lines by a promotional coupon that may be used to offset the Company intraLATA toll usage charges. Customers must redeem all coupons within 90 days of issuance. Coupons may not be redeemed for cash and have no value until presented to the Company for redemption toward the Company intraLATA toll usage.

Credits associated with this promotion will be provided to business customers with twenty or more exchange access lines by way of a credit on the Company bill. The credit will apply only toward the Company intraLATA toll usage on the bill.

2. Message toll Mobile Telephone Service is a communication service through a land radiotelephone station between a mobile unit and a wire telephone located outside the mobile service area associated with such land radio-telephone station, or between two mobile units served through land radio-telephone stations having different toll rate centers.

3. MOBILE TELEPHONE SERVICE - MTS (Cont'd)

B. REGULATIONS

1. Availability of Service

Mobile Telephone Service is available to mobile units equipped for this service when within range of a land radiotelephone station through which such service is furnished, and subject to transmission, atmospheric and like limitations.

2. Calls may be filed either to a specified person or to a specified telephone.

C. RATES

1. Applicable to messages completed through a mobile telephone service base station between a mobile unit and a wire telephone, when the wire telephone is outside the Mobile Service Area, or between two mobile units when the mobile telephone service base stations have different rate centers, except where extended area service is offered between the two rate centers.

a. The rates as determined from "TWO POINT MESSAGE TELECOMMUNICATION SERVICE" of this section apply between the toll rate center of the base station listed for "Mobile Telephone Service" and the toll rate center of the wire telephone involved or between the rate centers of the mobile telephone service base stations.

2. For service between a mobile unit and wire telephone within the mobile service area associated with the land radiotelephone station involved, or between two mobile units reached through land radiotelephone stations having the same toll rate center, the regulations and rates applicable are as provided under Mobile Telephone Service - Exchange.

6. HIGH VOLUME MESSAGE TELECOMMUNICATIONS SERVICE

A. DESCRIPTION

High Volume Message Telecommunications Service is that of furnishing telecommunications between stations in different local service areas in accordance with the regulations and systems of charges specified in this tariff. The toll service charges specified in this tariff are in payment for all service furnished between the calling and called telephones.

B. GENERAL REGULATIONS

1. Provision of Service

High Volume Message Telecommunication Service will be provided where suitable facilities and equipment permit.

2. Payment for Service

This tariff is filed under sec. 196.194, Wis. Stats. Therefore, any contract or amendment to such a contract shall be compensatory as determined under Sec. 196.204 (5) and (6) Wis. Stats. Within 20 days after a contract or an amendment to such a contract has been executed, the Company shall submit to the Commission written notice of the general nature of the contract and the parties to the contract.

3. The receipt of notification of any contract or amendment to a contract established under this tariff shall not constitute approval of all terms and provisions therein. The Commission retains jurisdiction to investigate on its own motion or upon complaint any contractual term or provision under which the tariffed service is offered, and to take any necessary action pursuant to such investigation, including issuing orders.

8. SERVICES ASSOCIATED WITH INTERSTATE DEDICATED ACCESS LINES**A. GENERAL**

Consistent with applicable federal tariffs, Interstate Dedicated Access Line Service may serve Intrastate calls depending on the screening and blocking options ordered by the customer. Where Intrastate capability exists, intrastate InterLATA calls originated through the use of the Interstate Dedicated Access Line will be directed to an Interexchange Carrier for completion. In such instance, access usage charges, including the Carrier Common Line charge specified in P.S.C. of W. No. 3 or the appropriate local exchange company intrastate access tariff will apply. Intrastate IntraLATA calls will be completed to the called station by the Company. Charges in accordance with the regulations and the Usage Charge schedule as specified for Outward WATS service in Part 10 apply. These charges will be billed to the customer of record for the Interstate Dedicated Access Line. When requested by the customer, and upon written agreement between the customer and the Company, the Company will bill the IntraLATA usage charges directly to the end user.
